ACTION ITEMS:

Consider Vehicle Leasing Program – this will be a government lease deal; we will realize a significant savings. We will be trading vehicles in while they still have some value. Worst-case scenario - \$387.84/month (includes maintenance) per car + fuel (\$51,200 for 11 vehicles). A motion was made by Bob Hermanson and seconded by Renee Linscheid to approve the vehicle leasing program with Enterprise. Consider Retirement Package – the retirement package being offered is \$12,000/year for three years, two payouts per year (August & January) – six payments deposited in TSA (403B) thru WEA (automatic deposit). This is a three-step process, one-time opportunity. CESA 3 will have the opportunity to consolidate positions. A motion was made by Mark Johnson and seconded by Bob Hermanson to approve the retirement package for staff. Upon roll call vote the following Board Members voted Aye: Bob Hermanson, Mike Humke, Mark Johnson, Renee Linscheid, Janet Matthes, Kim Schmelz, and JoAnn Wiederholt. Members voting no: none. Motion carried.
